He has worked since he was 12 years old and planned to work the rest of his life but, has beome disables due to his heart and back. He is only able to walk with a cane and needs numerous prescriptions to help him with all his health problems.

It already takes a substantial amount of his disablity earnings to cover co-pays for presriptions and Dr: office co-pays and that is with his insurance. Could you please help us to keep our insurance which is what he has worked 20 years for. Thank you so much for your time in reviewing this letter and listening to just one family's concerns. I am sure there are people that no insurance would hurt worse than this one family but, please keep the family struggles in mind when making a ruling in regards to the coal company's taking away our insurance.
