I get \$199.24 dollar a month from his pension. I really need my Insurance cause I have a pacemaker and have to have it check often. And it will be really for a new battery for it. I take Meds for high Blood Pressure Benicard Wafarin to keep my blood thin Bystolic to help with Blood pressure and stroke. I also take a stomach pill cause I had ulcers.

And so many surgery. I could not pay for all of this why would anyone, want to take away what our husbands worked so hard for in our older years in life. Please try to help us, keep what our husbands worked so
