PRIOR APPLICATIONS:

First Interim Application of Bowles Rice LLP for Allowance of Compensation filed November 16, 2012; Order entered December 19, 2012

1. On July 9, 2012 (the "<u>Petition Date</u>"), Patriot Coal Corporation and substantially all of its affiliated subsidiary companies ("<u>Debtors</u>") filed voluntary petitions for Chapter 11 Relief. [ECF No. 1]. Debtors' cases are being jointly administered by order of this Court. [ECF No. 30].

2. Prior to the Petition Date, Bowles Rice LLP ("<u>Bowles Rice</u>") rendered substantial legal services to Debtors in a wide range of areas.
