NOTICE IS FURTHER GIVEN that Claimant recorded a Notice of Mechanics' Lien in the county or counties in which the work was performed within one hundred days of the service dates pursuant to the West Virginia Mechanics' Lien Law.

NOTICE IS FURTHER GIVEN of the perfection of the Liens in the Property, including lots and tracts of land and upon the buildings, structure, and improvements thereon and proceeds, products, offspring, rents, and profits of such Property. A true and correct copy of the Claimant's recorded Notice(s) of Mechanics Lien and claim are attached hereto as Exhibit "1."
