Surratt-States, Chief United States Bankruptcy Judge (the "**Hearing**").<sup>3</sup> The Hearing may be adjourned or canceled by the Debtors by notice filed with the Bankruptcy Court, which notice will be made available at www.patriotcaseinfo.com, or announcement at the April 10, 2013 hearing.

PLEASE TAKE FURTHER NOTICE that the Debtors will seek entry at the Hearing of an Order Authorizing the Debtors to Reject Collective Bargaining Agreements and to Modify Retiree Benefits Pursuant to 11 U.S.C. §§ 1113, 1114 (the "Proposed Order").
