### **MOTION FOR TEMPORARY RESTRICTION**

Patriot Coal Corporation and its affiliated debtors (collectively, "Patriot" or the "Debtors"), respectfully submit this Motion for Temporary Restriction (the "Motion"), seeking order from the Court temporarily restricting from public view the Monthly Fee Statement of Steptoe & Johnson PLLC for Services Rendered and Reimbursement of Expenses Incurred as Special Counsel to the Debtors for the period of February 1, 2013 through February 28, 2013 [Docket No. 3309] (the "Fee Statement"). In support of the Motion, the Debtors respectfully state:

### **JURISDICTION**

1. This Court has subject matter jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b) and may be heard and determined by the Bankruptcy Court. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

#### REQUESTED RELIEF

- 2. On March 19, 2013, Steptoe & Johnson PLLC ("Steptoe") filed the Fee Statement with the Court. The Fee Statement contains detailed time records of Steptoe's work, attached as Exhibit D to the Fee Statement (the "Time Records"). The Time Records include information that should have been redacted prior to filing, such as the names and identifying personal information of employees of the Debtors.
- 3. The inclusion of such identifying information was an error and the public availability of such information regarding individual employees is harmful and improper. Pursuant to Fed. R. Bankr. P. 9037, the Fee Statement as originally filed should be sealed from public view immediately.
- 4. The Debtors have filed a Motion to Amend by Redaction [Docket No. 3355] requesting that the Court enter an order directing the Fee Statement as it was originally filed to be placed under seal, and directing that a redacted version of the Fee Statement, attached thereto as Exhibit A, replace the original filing on the docket.
- 5. Until the Motion to Amend by Redaction is granted, the Debtors request that the Court temporarily restrict from public view the Fee Statement.
- 6. The requested relief will not impact the substantive rights of the Debtor, any creditor or any other party in interest.

WHEREFORE, the Debtors respectfully request that the Court enter an order temporarily restricting from public view the Fee Statement, and for such other and further relief as is just and proper.
