We never worked for Patriot Coal. We retired from Peabody Hymville mine + they closed my old Ben Coal Co #1 Mine here.

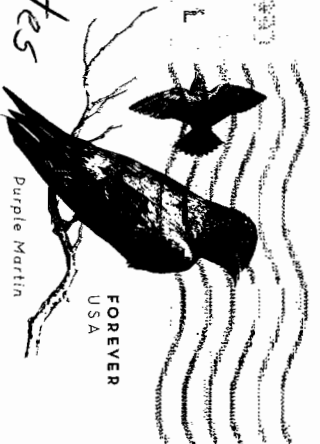
