Therefore, I am writing to respectfully request that any rulings made by the courts would protect the benefits that have been contractually provided to the Patriot employees, who are my brothers and sisters in Christ, friends and neighbors.

The area we live, worship and work in, north central West Virginia, is rich in coal deposits. Therefore these family's for many years and generations have made there livelihood by bringing these coal deposits out of the ground and to market to provide the energy needed for all commerce.
