MOTION TO EXPEDITE DEBTORS' MOTION TO (i) COMPEL AURELIUS CAPITAL MANAGEMENT, LP, KNIGHTHEAD CAPITAL MANAGEMENT, LLC AND THEIR COUNSEL TO COMPLY WITH BANKRUPTCY RULE 2019 AND (ii) PROHIBIT FURTHER PARTICIPATION IN THESE CASES BY AURELIUS CAPITAL MANAGEMENT, LP, KNIGHTHEAD CAPITAL MANAGEMENT, LLC AND THEIR COUNSEL PENDING COMPLIANCE WITH BANKRUPTCY RULE 2019

Patriot Coal Corporation and its affiliated debtors respectfully move, pursuant to Rule 9013-2(A) of the Local Rules of the Bankruptcy Court for the Eastern District of Missouri (the "Local Rules"), for an order expediting the Debtors' Motion to (i) Compel Aurelius Capital Management, LP, Knighthead Capital Management, LLC and their Counsel to Comply with Bankruptcy Rule 2019 and (ii) Prohibit Further Participation in these Cases by Aurelius Capital Management, LP, Knighthead Capital Management,

LLC and their Counsel Pending Compliance With Bankruptcy Rule 2019 (the "Rule 2019 Motion")² [ECF No. 3682] and scheduling the Rule 2019 Motion for hearing at the Debtors' April status hearing on April 23, 2013 at 10:00 a.m. (Central Time).

Additionally, the Debtors respectfully seek a waiver of paragraph 12(a) of the Court's Order Establishing Certain Notice, Case Management and Administrative Procedures [ECF No. 3361] (the "Case Management Order") with respect to the Rule 2019 Motion, thereby allowing the Rule 2019 Motion to be heard on less than 21-days' notice.

BACKGROUND AND JURISDICTION

- 1. On July 9, 2012 (the "**Petition Date**"), each Debtor commenced a voluntary case under chapter 11 of the Bankruptcy Code. The Debtors are authorized to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. The Debtors' cases are being jointly administered pursuant to Bankruptcy Rule 1015(b) and the Joint Administration Order entered on July 10, 2012 [ECF No. 30].
- 2. On March 28, 2013, the Noteholder Group, an informal group of creditors that holds (according to the Noteholder Group) a substantial amount of Patriot's 3.25% Convertible Senior Notes due 2013 and 8.25% Senior Notes due 2018, filed the Motion of Aurelius Capital Management, LP, and Knighthead Capital Management, LLC, for Entry of an Order, Pursuant to 11 U.S.C. §§ 105(a) and 1104(a), Directing the Appointment of a Chapter 11 Trustee [ECF No. 3423] (the "**Trustee Motion**"). On April 12, 2013, the Noteholder Group filed the Noteholders' Objection to Motion to Reject

Collective-Bargaining Agreements and to Modify Retiree Benefits Pursuant to 11 U.S.C. §§ 1113 and 1114 [ECF No. 3608] (the "1113/1114 Objection"). Aside from the very basic facts contained in these pleadings, very little is definitively known about the Noteholder Group – largely because they and their counsel have not complied with the mandatory disclosure requirements of Bankruptcy Rule 2019.

- 3. Today, April 16, 2013, the Debtors filed an objection to the Trustee Motion [ECF No. 3675.
- 4. This Court has subject matter jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b) and may be heard and determined by this Court. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

BASIS FOR RELIEF

- 5. Rule 9013-2(A) of the Local Rules provides that an emergency or expedited hearing may be granted upon a movant's "written motion, setting forth the reason the matter should be heard on an expedited or emergency" basis.
- 6. The Rule 2019 Motion simply requests that the Court compel the Noteholder Group to comply with the disclosure requirements of Bankruptcy Rule 2019 so that the Court, the United States Trustee, the Debtors, the official committee of unsecured creditors, and other parties in interest may be able to fully and accurately evaluate the actions and intentions of the Noteholder Group. Such information should be readily available to the Noteholder Group and filed with this Court pursuant to Bankruptcy Rule 2019. Delaying consideration of the Rule 2019 Motion beyond April 23, 2013 would allow the Noteholder Group to be heard with respect to the Trustee Motion, which seeks an extraordinary remedy, and any further delay beyond April 29,

2013 would allow the Court to consider the 1113/1114 Objection, all without obligating the Noteholder Group to provide the required information. The sanctions for non-compliance with Bankruptcy Rule 2019 allow the Court to, among other things, "refuse to permit the . . . group . . . to be heard or to intervene in the case."

NOTICE

7. Consistent with the Case Management Order, the Debtors will serve notice of this motion on the Core Parties. All parties who have requested electronic notice of filings in these cases through the Court's ECF system will automatically receive notice of this motion through the ECF system no later than the day after its filing with the Court. A copy of this motion and any order approving it will also be made available on the Debtors' Case Information Website (located at www.patriotcaseinfo.com).

WHEREFORE the Debtors respectfully request that the Court enter an order scheduling the Rule 2019 Motion for hearing on an expedited basis at the Debtors' April status hearing scheduled for April 23, 2013 at 10:00 a.m. (prevailing Central Time).
