MOTION TO STRIKE THE SECOND OBJECTION OF THE OHIO VALLEY COAL COMPANY AND THE OHIO VALLEY TRANSLOADING COMPANY TO THE DEBTORS' MOTION TO REJECT COLLECTIVE BARGAINING AGREEMENTS AND TO MODIFY RETIREE BENEFITS PURSUANT TO 11 U.S.C. §§ 1113, 1114

Patriot Coal Corporation and its affiliated debtors (collectively, "Patriot" or the "Debtors") respectfully move to strike the Brief in Support of Objection of the Ohio Valley Coal Company and the Ohio Valley Transloading Company to the Motion to Reject Collective Bargaining Agreements and to Modify Retiree Benefits Pursuant to 11 U.S.C. §§ 1113,1114 (the "Second Objection") [ECF No. 3617] (the "Motion").

ARGUMENT

- 1. Pending before the Court is the Debtors' March 14, 2013 Motion to Reject Collective Bargaining Agreements and to Modify Retiree Benefits Pursuant to 11 U.S.C. §§ 1113,1114 (the "1113/1114 Motion") [ECF No. 3214].
- 2. On March 19, 2013, The Ohio Valley Coal Company and the Ohio Valley Transloading Company (together, "Ohio Valley Coal") filed its Objection to Motion to Reject

Collective Bargaining Agreements and to Modify Retiree Benefits Pursuant to 11 U.S.C. §§ 1113, 1114 (the "**Original Objection**") [ECF No. 3326], comprising eleven pages.

- 3. On April 5, 2013, the Court issued an order setting out guidelines for third-party intervention in this matter (the "Intervention Order") [ECF No. 3543]. The Intervention Order granted certain third parties, including Ohio Valley Coal, limited rights to participate in the §§ 1113, 1114 proceeding and in discovery. In particular, the Intervention Order limits third parties like Ohio Valley Coal to "a brief in support of their position . . . regarding" the 1113/1114 Motion "of 15 pages or less."
- 4. On April 12, 2013, in contravention of the Intervention Order, Ohio Valley Coal filed the Second Objection, styled as a "brief in support" of its objection, and comprising an additional eleven pages.
- 5. Although Ohio Valley Coal disingenuously styles the Second Objection as a "brief in support" of its objection, the Second Objection is identical to the Original Objection in form, if not in content. Even a cursory review of the two filings makes plain that they both serve the same purpose: advancing arguments against the 1113/1114 Motion. The Second Objection is a transparent attempt to circumvent the page and briefing limits imposed by the Court to advance variations on the arguments of the Original Objection. The Court should reject this second bite at the apple and strike the Second Objection.

NOTICE

6. Consistent with the Order Establishing Certain Notice, Case Management and Administrative Procedures entered on March 22, 2013 (as may be amended, the "Case Management Order") [ECF No. 3361], the Debtors will serve notice of this Motion on (a) the Core Parties and (b) the Particularized Interest Parties (as those terms are defined in the Case

Management Order). All parties who have requested electronic notice of filings in these cases through the Court's ECF system will automatically receive notice of this motion through the ECF system no later than the day after its filing with the Court. A copy of this Motion and any order approving it will also be made available on the Debtors' Case Information Website (located at *www.patriotcaseinfo.com*).

WHEREFORE the Debtors respectfully request that the Court grant the Debtors' Motion and strike the Second Objection.
