<u>DEBTORS' FIFTH OMNIBUS OBJECTION TO CLAIMS</u> (Wrong Debtor or Otherwise Inconsistent with Books and Records)

Patriot Coal Corporation and its affiliated debtors (the "Debtors"), pursuant to 11 U.S.C. § 502 and Fed. R. Bankr. P. 3007, respectfully file this Fifth Omnibus Objection to Claims (the "Objection"). In support of this Objection, the Debtors show the Court as follows:

Relief Requested

- 1. By this Objection, the Debtors object to certain claims listed on Exhibit A through Exhibit H attached hereto (the "Claims") because the Claims have been filed against the wrong Debtor, with an incorrect priority, and/or in an inaccurate amount. The Debtors request entry of an order, pursuant to Section 502 of the Bankruptcy Code and Fed. R. Bankr. P. 3007, disallowing and/or modifying the Claims as indicated on the exhibits to this Objection.
- 2. Parties receiving this Objection should locate their names on one or more of the attached exhibits. Any response to this Objection should include, among other things, (i) an appropriate caption, including the title and date of this Objection; (ii) the name of the claimant, both the EDMO and GCG claim numbers of the claim that the Debtors are seeking to disallow or modify, and a description of the basis for the amount claimed; (iii) a concise statement setting

forth the reasons why the Court should not sustain this Objection, including, but not limited to, the specific factual and legal bases upon which the claimant relies in opposing this Objection; (iv) copies of any documentation and other evidence which the claimant will rely upon in opposing this Objection at a hearing; and (v) the name, address, telephone number and facsimile number of a person authorized to reconcile, settle or otherwise resolve the claim on the claimant's behalf. A claimant that cannot timely provide such documentation and other evidence should provide a detailed explanation as to why it is not possible to timely provide such documentation and other evidence.

Jurisdiction

- 3. This Court has jurisdiction over this Objection under 28 U.S.C. § 1334. Venue of this proceeding is proper pursuant to 28 U.S.C. § 1409. This is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).
 - 4. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

Background

- 5. The Debtors filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code on July 9, 2012 (the "Petition Date") in the United States Bankruptcy Court for the Southern District of New York.
- 6. On December 19, 2012, the Debtors' cases were transferred to the United States Bankruptcy Court for the Eastern District of Missouri [Dkt. No. 1789].
 - 7. The bar date for filing proofs of claim was December 14, 2012 [Dkt. No. 1388].

8. On March 1, 2013, the Court entered its Order Establishing Procedures for Claims Objections [Dkt. No. 3021].

Objection and Argument

Wrong Debtor Claims

- 9. The Debtors object to each of the Claims identified on Exhibit A, incorporated herein by reference (the "Wrong Debtor Claims"), because it has been filed against a Debtor that is not liable for it.¹
- 10. Exhibit A sets forth the name of the Debtor against which each Wrong Debtor Claim was filed (the "Claimed Debtor"). The Debtors have reviewed each of the Wrong Debtor Claims and have determined that the Claimed Debtor does not have a business relationship with the creditor asserting the Claim or that the Claim does not arise out of the relationship between the Claimed Debtor and the creditor. *See* Declaration of Robert L. Mead, attached hereto as Exhibit I. Rather, the Wrong Debtor Claim relates to the creditor's relationship with the Debtor identified on Exhibit A as the "Reassigned Debtor."
- 11. The Debtors request that the Court disallow each of the Wrong Debtor Claims as a Claim against the Claimed Debtor and that the claims register be modified to identify each Wrong Debtor Claim as asserted against the applicable Reassigned Debtor. Although the Debtors do not dispute the amounts of the Wrong Debtor Claims, the Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Wrong Debtor Claims on any ground.

¹ Certain creditors listed on the exhibits hereto may be clients of one or more of the law firms representing the Debtors. Any dispute regarding this Objection will be handled by attorneys for the Debtors from a law firm that does not represent the applicable creditor.

Wrong Priority Claims

- 12. The Debtors object to each of the Claims identified on <u>Exhibit B</u>, incorporated herein by reference (the "Wrong Priority Claims"), because it asserts secured status, administrative-expense priority, or statutory priority in amounts that are inaccurate.
- 13. Exhibit B sets forth the amounts included in each Wrong Priority Claim, including the amounts claimed by the creditor to be secured claims, administrative-expense priority claims, statutory-priority claims, and general unsecured claims. The Debtors have reviewed each of the Wrong Priority Claims and have determined that the priorities claimed by the creditor are, in whole or in part, inconsistent with the nature of the parties' obligations and the requirements for secured or priority status in this case. *See* Declaration of Robert L. Mead. Exhibit B also includes what the Debtors believe to be the appropriate treatment of each of the Wrong Priority Claims, in accordance with the Debtors' books and records, the business relationship between the Debtors and the creditor, and the requirements of the law (the "Reclassified Claim").
- 14. The Debtors request that each of the Wrong Priority Claims be modified in the claims register to reflect the priorities of the applicable Reclassified Claim. Although the Debtors do not dispute the total amounts of the Reclassified Claims, the Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Reclassified Claims on any ground.

Wrong Amount Claims

- 15. The Debtors object to each of the Claims identified on Exhibit C-1, incorporated herein by reference (the "Wrong Amount Claims"), because it exceeds the amount owed to the applicable creditor as of the Petition Date.
- 16. Exhibit C-1 identifies each Wrong Amount Claim. The Debtors have reviewed each of the Wrong Amount Claims and have determined that the amount claimed by the creditor exceeds the applicable Debtor's obligation to the creditor as of the Petition Date. *See* Declaration of Robert L. Mead. Exhibit C-1 also includes what the Debtors believe to be the appropriate amount of each of the Wrong Amount Claims, in accordance with the Debtors' books and records and the business relationship between the Debtors and the creditor (the "Reduced Claim").
- 17. The Debtors request that each of the Wrong Amount Claims be modified in the claims register to reflect the amount of the applicable Reduced Claim. The Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Reduced Claims on any ground.

Zero Amount Claims

18. The Debtors object to each of the Claims identified on Exhibit C-2, incorporated herein by reference (the "Zero Amount Claims"), because the Debtors' books and records reflect

that the Debtors were not liable to the applicable creditor on account of the Zero Amount Claims as of the Petition Date.²

- 19. Exhibit C-2 identifies each Zero Amount Claim. The Debtors have reviewed each of the Zero Amount Claims and have determined that, for the reasons described in further detail on Exhibit C-2, the Debtors do not have any liability to the creditor on account of the Zero Amount Claim. *See* Declaration of Robert L. Mead.
- 20. The Debtors thus request that the Court disallow each of the Zero Amount Claims.

Wrong Debtor and Wrong Priority Claims

- 21. The Debtors object to each of the Claims identified on Exhibit D, incorporated herein by reference (the "Wrong Debtor/Wrong Priority Claims"), because it is both a Wrong Debtor Claim and a Wrong Priority Claim.
- 22. Exhibit D identifies each Wrong Debtor/Wrong Priority Claim, as well as what the Debtors believe to be appropriate treatment of such Claim (the "Modified Claim").
- 23. The Debtors request that the Court disallow each of the Wrong Debtor/Wrong Priority Claims as a Claim against the Claimed Debtor and that the claims register be modified to identify each Wrong Debtor/Wrong Priority Claim as asserted against the applicable Reassigned Debtor in the amount and with the priorities reflected in the applicable Modified Claim. The Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Modified Claims on any ground.

 $^{^2}$ This Objection is limited to the Zero Amount Claims and does not affect any other Claims asserted by the affected creditors.

Wrong Debtor and Wrong Amount Claims

- 24. The Debtors object to each of the Claims identified on <u>Exhibit E</u>, incorporated herein by reference (the "Wrong Debtor/Wrong Amount Claims"), because it is both a Wrong Debtor Claim and a Wrong Amount Claim.
- 25. Exhibit E identifies each Wrong Debtor/Wrong Amount Claim, as well as what the Debtors believe to be the appropriate Modified Claim.
- 26. The Debtors request that the Court disallow each of the Wrong Debtor/Wrong Amount Claims as a Claim against the Claimed Debtor and that the claims register be modified to identify each Wrong Debtor/Wrong Priority Claim as asserted against the applicable Reassigned Debtor in the amount reflected in the applicable Modified Claim. The Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Modified Claims on any ground.

Wrong Priority and Wrong Amount Claims

- 27. The Debtors object to each of the Claims identified on Exhibit F, incorporated herein by reference (the "Wrong Priority/Wrong Amount Claims"), because it is both a Wrong Priority Claim and a Wrong Amount Claim.
- 28. Exhibit F identifies each Wrong Priority/Wrong Amount Claim, as well as what the Debtors believe to be the appropriate Modified Claim.
- 29. The Debtors request that each of the Wrong Priority/Wrong Amount Claims be modified in the claims register to reflect the priorities and amount of the applicable Modified

Claim. The Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Modified Claims on any ground.

Wrong Debtor, Wrong Priority, and Wrong Amount Claims

- 30. The Debtors object to each of the Claims identified on Exhibit G, incorporated herein by reference (the "Wrong Debtor/Wrong Priority/Wrong Amount Claims"), because it is a Wrong Debtor Claim, a Wrong Priority Claim, and a Wrong Amount Claim.
- 31. Exhibit G identifies each Wrong Debtor/Wrong Priority/Wrong Amount Claim, as well as what the Debtors believe to be the appropriate Modified Claim.
- 32. The Debtors request that the Court disallow each of the Wrong Debtor/Wrong Priority/Wrong Amount Claims as a Claim against the Claimed Debtor and that the claims register be modified to identify each Wrong Debtor/Wrong Priority/Wrong Amount Claim as asserted against the applicable Reassigned Debtor in the amount and with the priorities reflected in the applicable Modified Claim. The Debtors request that the Court's order sustaining this Objection be without prejudice to the right of any party in interest to object to the Modified Claims on any ground.

Claim Filed Against a Non-Debtor

33. The Debtors object to the Claim identified on Exhibit H, incorporated herein by reference (the "Florida Claim"), because it is asserted against Kare Distribution, Inc.³

³ For administrative purposes, the Debtors' claims agent has docketed the Florida Claim on the claims register of Debtor Patriot Coal Corporation, but both the proof of claim and the backup information refer to Kare Distribution, Inc. as the debtor. The Florida Claim appears to have been filed with the Clerk of the United States Bankruptcy Court for the Southern District of New York and forwarded to the claims agent.

- 34. Kare Distribution, Inc. is neither a Debtor nor a name under which any of the Debtors does business. *See* Declaration of Robert L. Mead. The Debtors have reviewed the Florida Claim and are aware of no basis on which they would be liable to the Attorney General of Florida on account of the Florida Claim. *See id*.
 - 35. The Debtors thus request that the Court disallow the Florida Claim.

WHEREFORE, the Debtors respectfully request that this Court:

- (a) disallow and/or modify the Claims, as described above; and
- (b) grant such other and further relief as is just and proper.

 - (a) The Debtors' books and records reflect that the applicable Debtor was not liable to the creditor for the Zero Amount Claim as of the Petition Date.

- (b) Exhibit C-2 also includes a more detailed explanation of the Debtors' determination that the applicable Debtor had no liability to the creditor. This explanation is true and correct to the best of my knowledge, information, and belief.

 - (b) Exhibit F also includes what the Debtors believe to be the appropriate treatment of the Wrong Priority/Wrong Amount Claim, in accordance with the Debtors' books and records, the business relationship between the Debtors and the creditor, and the requirements of the law.
- 9. I, or my colleagues, have reviewed each of the proofs of claim identified on Exhibit G to the Debtors' Fifth Omnibus Objection to Claims (the "Wrong Debtor/Wrong Priority/Wrong Amount Claims"). With respect to each of these Claims:
 - (a) For the reasons stated in the applicable paragraphs above, the Claim is a Wrong Debtor Claim, a Wrong Priority Claim, and a Wrong Amount Claim.
 - (b) Exhibit G also includes what the Debtors believe to be the appropriate treatment of the Wrong Debtor/Wrong Priority/Wrong Amount Claim, in accordance with the Debtors' books and records, the business relationship between the Debtors and the creditor, and the requirements of the law.
- 10. I, or my colleagues, have reviewed the proof of claim identified on Exhibit H to the Debtors' Fifth Omnibus Objection to Claims (the "Florida Claim"). The Florida Claim is asserted against Kare Distribution, Inc., which is neither a Debtor nor a name under which any of the Debtors does business. The Debtors are aware of no basis on which they would be liable to the Attorney General of Florida on account of the Florida Claim.
