## RESPONSE OF C&A CUTTERHEAD, INC. TO CLAIM OBJECTION FILED BY DEBTOR

Now comes C&A Cutterhead, Inc. ("C&A"), through its undersigned counsel, and for its response to the Debtors' Fifth Omnibus Objection to Claims (Docket # 4181) and Notice of Claim Objection issued by Patriot (collectively the "Objection") respectfully states as follows:

- 1. C&A timely filed its Proof of Claim, being designated as EDMO/DCG Claim # 2850-1/804 asserting an administrative expense priority claim pursuant to 11 U.S.C. § 503(b)(9) in the amount of \$2,440.00 (the "Claim"). A true copy of the Claim is attached hereto as Exhibit A.
- 2. By filing the Claim, C&A introduced prima facie evidence that the claim is both valid and accurate. The Debtor cannot shift the burden to prove the validity of the Claim without providing evidence showing that the Claim is not accurate. Unless the Debtor successfully shifts the burden to C&A and C&A fails to satisfy the burden, the C&A Claim must prevail. *In re Nejedlo*, 324 B.R. 697, 699 (Bankr. E.D. Wis. 2005).
- 3. On February 27, 2013, the Debtor filed a Report (the "Report") stating that the Claim had been paid as its sole ground for disallowance of the Claim. Pursuant to its Response

to the Report (Docket # 3315) filed on March 19, 2013, C&A confirmed that it had <u>not</u> received

payment upon the Claim or otherwise for amounts asserted in the Claim.

4. The sole grounds cited in the Objection are that the priorities asserted in the Claim

are inconsistent, in whole or in part, with the nature of the parties' obligations and requirements

for secured or priority status. The Objection seeks to reduce the 503(b)(9) administrative

expense priority portion of the Claim to \$1,610.00 and allow the remaining balance (\$830.00) as

a general unsecured claim. No grounds exist to support the Objection and/or the relief sought by

the Debtor.

WHEREFORE, C&A Cutterhead Company respectfully requests that the Court overrule

the Objection, that the Claim be deemed allowed in full as entitled to administrative expense

priority pursuant to 11 U.S.C. § 503(b)(9)together with such other and further relief as is proper

and just.
