ORDER SUSTAINING DEBTORS' FIFTH OMNIBUS OBJECTION TO CLAIMS (Wrong Debtor or Otherwise Inconsistent with Books and Records)

On June 20, 2013, Patriot Coal Corporation and its subsidiaries that are debtors in these jointly-administered cases (the "Debtors") filed their Fifth Omnibus Objection to Claims (Wrong Debtor or Otherwise Inconsistent with Books and Records) (the "Objection"). Capitalized terms not defined herein have the meanings set forth in the Objection.

Upon consideration of the Objection, the Declaration of Robert L. Mead attached to the Objection, the exhibits to the Objection, and the related certificate of service, it appears that notice of the Objection was sufficient and proper and that good cause exists for sustaining the Objection as to the Claims addressed in this Order.

Accordingly, it is hereby ORDERED as follows:

1. As to the Claims of the following creditors, the Objection is ADJOURNED to August 20, 2013 at 10:00 a.m. in Courtroom 7-North (the "Adjourned Claims"): Guyan Service Company (E.D. Mo. Claim No. 240; GCG Claim No. 237); C&A Cutterhead Inc. (E.D. Mo. Claim No. 2850; GCG Claim No. 804); State of Michigan, Department of Treasury (E.D. Mo. Claim Nos. 200 and 206; GCG Claim Nos. 196 and 202); Alpha Records Management Inc. (E.D. Mo. Claim No. 457; GCG Claim No. 522); Hawthorn Bank (E.D. Mo. Claim Nos. 26, 27, 28,

- 30, 31, 396; GCG Claim Nos. 22, 23, 24, 26, 27, 3988); Robert Johns, Trustee for Panther Branch (E.D. Mo. Claim No. 3866-2; GCG No. 1776); Ohio Department of Job and Family Services (E.D. Mo. Claim No. 2300-1; GCG Claim No. 3670); Hulin H. Cook, Jr. (E.D. Mo. Claim Nos. 3257 and 3299; GCG Claim Nos. 3725 and 3726); Electro-Mechanical Corporation (E.D. Mo. Claim No. 3675; GCG Claim No. 1987); Petroleum Products LLC (E.D. Mo. Claim Nos. 389602, 1400, 1401, 1402, 1692, 1699, 1501, 1502, 1503, 1405, 1686, 1695, 1498, 1404; GCG Claim Nos. 2361, 2366, 2367, 2368, 2610, 2612, 2363, 2364, 2365, 2370, 2608, 2611, 2362, 2369); David Cox (E.D.  - 2. The Objection is SUSTAINED as to all Claims other than the Adjourned Claims.
- 3. Each of the Wrong Debtor Claims is hereby disallowed as a Claim against the applicable Claimed Debtor. The claims register shall be modified to identify each Wrong Debtor Claim as asserted against the applicable Reassigned Debtor identified on Exhibit A to the Objection.
- 4. Each of the Wrong Priority Claims shall be modified in the claims register to reflect the priorities of the applicable Reclassified Claim identified on Exhibit B to the Objection.
- 5. Each of the Wrong Amount Claims shall be modified in the claims register to reflect the amount of the applicable Reduced Claim identified on Exhibit C to the Objection.
 - 6. Each of the Zero Amount Claims is hereby disallowed.
- 7. Each of the Wrong Debtor/Wrong Priority Claims is hereby disallowed as a Claim against the applicable Claimed Debtor. The claims register shall be modified to identify each Wrong Debtor/Wrong Priority Claim as asserted against the applicable Reassigned Debtor in the

amount and with the priorities reflected in the applicable Modified Claim identified on Exhibit D to the Objection.

- 8. Each of the Wrong Debtor/Wrong Amount Claims is hereby disallowed as a Claim against the Claimed Debtor. The claims register shall be modified to identify each Wrong Debtor/Wrong Priority Claim as asserted against the applicable Reassigned Debtor in the amount reflected in the applicable Modified Claim identified on Exhibit E to the Objection.
- 9. Each of the Wrong Priority/Wrong Amount Claims shall be modified in the claims register to reflect the priorities and amount of the applicable Modified Claim identified on Exhibit F to the Objection.
- 10. Each of the Wrong Debtor/Wrong Priority/Wrong Amount Claims is hereby disallowed as a Claim against the Claimed Debtor. The claims register shall be modified to identify each Wrong Debtor/Wrong Priority/Wrong Amount Claim as asserted against the applicable Reassigned Debtor in the amount and with the priorities reflected in the applicable Modified Claim identified on Exhibit G to the Objection.
 - 11. The Florida Claim is hereby disallowed.
- 12. The Clerk of the Court and the Debtors' claims agent are hereby directed to reflect the disallowance and/or modification of the Claims, as specified above, in their respective records.

13. Nothing in this Order affects the right of any party in interest to object to any

Claim on any grounds.
