# MOTION TO WITHDRAW AS COUNSEL FOR ALPHA ENGINEERING SERVICES, INC.

Now comes James W. Lane, Jr. (Lane) counsel of record for Alpha Engineering Services, Inc. (Alpha), and pursuant to Local Rule 2091, respectfully moves the Court to withdraw as counsel, and in support asserts the following:

- 1. Lane is counsel of record for Alpha. Alpha is an engineering firm in Beckley, West Virginia, and Alpha has performed engineering work for three mine sites for which it has claims for prepetition services. Alpha has filed proofs of claim against Patriot Coal Corporation and other debtors asserting mechanic's lien claims against the respective coal mines, pursuant to the West Virginia mechanic's lien statute.
- Lane recently joined the law firm Flaherty Sensabaugh Bonasso, PLLC
   (FSB). FSB represents the Debtors in workplace injury lawsuits and claims pending in West Virginia.
- 3. Lane's continued representation of Alpha would create a direct conflict of interest under Rule 1.7 of the West Virginia Rules of Professional Conduct because Lane's continued representation of Alpha with respect to its claims against Patriot would be directly adverse to Patriot, a client of Lane's new firm. Patriot has declined to consent to Lane's continued representation of Alpha. Rule 1.7 provides that a lawyer

"shall not" represent a client under these circumstances.

4. Lane has explained to Alpha that he must withdraw as counsel under the

circumstances. Steven L. Thomas, at attorney in Charleston, West Virginia, together

with his firm, Kay Casto & Chaney, PLLC, have agreed with Alpha to be substituted in

place of Lane as counsel for Alpha in this case.

5. Pending in this case is the Debtors' Fifteenth Omnibus Objection to redundant

proofs of claim, which objects a proof of claim that Alpha filed against Patriot Coal

Corporation as a redundant claim. Alpha filed a response to the Objection. A hearing is

presently scheduled on the matter for October 22, 2013 at 10:00 a.m.

Wherefore, James W. Lane, Jr. respectfully requests that the Court authorize

Lane to withdraw as counsel.
