I, MICHAEL D. WARNER, ESQ., pursuant to 28 U.S.C. § 1746, hereby declare under penalty of perjury that the following is true and correct to the best of my knowledge, information and belief:

1. I am an attorney at law and in good standing to practice in the States of Texas and California, and as of February 22, 2013, I am admitted *pro hac vice* to the bar of the Eastern District of Missouri (Order Granting *Motion for Admission Pro Hac Vice* [Docket No. 2898]). I am a Member of the law firm of Cole, Schotz, Meisel, Forman & Leonard, P.A. ("<u>Cole Schotz</u>"), and I am duly authorized to make this first supplemental declaration ("<u>First Supplemental Declaration</u>") on behalf of Cole Schotz.

2. This First Supplemental Declaration is submitted in support of the *Application of the Official Committee of Unsecured Creditors of Patriot Coal Corporation*, <u>et al.</u> for Order *Authorizing and Approving the Employment and Retention of Cole, Schotz, Meisel, Forman & Leonard, P.A. as its Conflicts Counsel, Effective August 16, 2012* (the "Cole Schotz Retention Application") [Docket No. 442], filed in the above-captioned chapter 11 cases (the "Chapter 11 Cases") and in furtherance of Cole Schotz's ongoing disclosure obligations under Rule 2014 of the Federal Rules of Bankruptcy Procedure and pursuant the Order Authorizing and Approving

the Official Committee of Unsecured Creditors of Patriot Coal Corporation, et al. to Employ and Retain Cole, Schotz, Meisel, Forman & Leonard, P.A. as Conflicts Counsel, Effective August 16, 2012 [Docket No. 536] authorizing the employment of Cole Schotz as conflicts counsel for the Official Committee of Unsecured Creditors (the "Committee") of the above captioned debtors and debtors in possession (collectively the "Debtors"). This First Supplemental Declaration supplements the Declaration of Michael D. Warner, Esq. in Support of the Application of the Official Committee of Unsecured Creditors of Patriot Coal Corporation, et al., for order Authorizing and Approving the Employment and Retention of Cole, Schotz, Meisel, Forman & Leonard, P.A. as its Conflicts Counsel, Effective August 16, 2012 [Docket No. 442, Exhibit A] (the "Prior Declaration") which was submitted in support of the Cole Schotz Retention Application.

3. Unless otherwise stated in this First Supplemental Declaration, the facts set forth are personally known to me and, if called as a witness, I could and would testify thereto.

4. On September 23, 2013, Brody Mining, LLC and Patriot Ventures LLC (the "<u>New Debtors</u>") each filed voluntary petitions for relief pursuant to Chapter 11 of the Bankruptcy Code and on September 26, 2013, the Court granted the Debtors' Motion for Joint Administration of Brody Mining, LLC, Case No. 13-48727 [Docket No. 16] and Patriot Ventures LLC, Case No. 13-48728 [Docket No. 16] with Lead Case No. 12-51502.

5. Given the New Debtors' Chapter 11 cases, Cole Schotz conducted a search, using the procedures described in the Prior Declaration dated August 28, 2012, of its conflicts database using the names provided by the Debtors of the principal parties in interest in the New Debtors' Chapter 11 Cases, which are listed on **Exhibit A** hereto.

6. The search described above revealed no connections requiring disclosure.

Based upon the foregoing, insofar as I have been able to ascertain after diligent inquiry, I continue to believe that Cole Schotz does not hold or represent an interest adverse to the Committee, the Debtors, the New Debtors, or their estates in the matters upon which Cole Schotz is employed, and Cole Schotz remains "disinterested" as such term is defined in section 101(14) of title 11 of the United States Code.

To the extent that any information disclosed herein requires subsequent amendment or modification upon Cole Schotz's completion of further analysis or if any new, material, relevant facts or relationships are discovered, one or more supplemental declarations on behalf of Cole Schotz will be submitted to the Court reflecting such amended or modified information.
