MOTION TO AMEND BY REDACTION

Patriot Coal Corporation and its affiliates (collectively, the "Debtors" or the "Reorganized Debtors"), respectfully submit this Motion to Amend by Redaction (the "Motion"), seeking an order from the Court amending the Fourth and Final Fee Application of Jackson Kelly PLLC for Services Rendered and Reimbursement of Expenses Incurred as Special Counsel to the Debtors [Docket No. 5321] (the "Fee Application"). In support of the Motion, the Reorganized Debtors respectfully state:

JURISDICTION

1. This Court has subject matter jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b) and may be heard and determined by the Bankruptcy Court. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

REQUESTED RELIEF

- 2. On January 31, 2014, Jackson Kelly PLLC ("Jackson Kelly") filed the Fee Application with the Court. The Fee Application contains detailed time records of Jackson Kelly's work, attached as Exhibit D to the Fee Statement (the "Time Records"). The Time Records include information that should have been redacted prior to filing, such as the personal identifying information of the Reorganized Debtors' employees, including their social security numbers.
- 3. The inclusion of such identifying information was an error and the public availability of such information regarding individual employees is harmful and improper. Pursuant to Fed. R. Bankr. P. 9037, the Fee Application as originally filed should be sealed from public view immediately.
- 4. The Reorganized Debtors request that the Court enter an order directing the Fee Application as it was originally filed to be placed under seal, and directing that a redacted version of the Fee Statement, attached hereto as <u>Exhibit A</u>, replace the original filing on the docket.
- 5. The requested relief will not impact the substantive rights of the Reorganized Debtors, any creditor or any other party in interest.

WHEREFORE, the Reorganized Debtors respectfully request that the Court enter an order directing that the Fee Application as originally filed be replaced with the redacted version of the same, attached hereto as Exhibit A, and for such other and further relief as is just and proper.

AMENDED FOURTH AND FINAL APPLICATION OF JACKSON KELLY PLLC FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES

Jackson Kelly PLLC ("<u>Jackson Kelly</u>"), special counsel to Patriot Coal Corporation and its subsidiaries that are debtors and debtors in possession in these proceedings (collectively, the "<u>Debtors</u>"), hereby files its final application (the "<u>Application</u>"), pursuant to sections 330(a) and 331 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") and Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), for (i) allowance of compensation for professional services performed, and reimbursement of its actual and necessary expenses incurred, by Jackson Kelly during the period commencing August 1, 2013 through and including December 31, 2013 (the "<u>Fourth Compensation Period</u>") and (ii) final

allowance of compensation for professional services performed, and reimbursement of its actual and necessary expenses incurred, by Jackson Kelly during the period commencing July 9, 2012 through and including December 31, 2013 (the "Entire Compensation Period"), respectfully represents as follows:

BACKGROUND

- 1. On July 9, 2012 (the "Petition Date"), the Debtors filed voluntary petitions for Chapter 11 Relief. [See ECF No. 1]. Debtors' cases are being jointly administered by order of this Court. [ECF No. 30]. Pursuant to the December 12, 2012, Order Transferring Venue, the Debtors' cases were transferred from the United States Bankruptcy Court for the Southern District of New York to the United States Bankruptcy Court for the Eastern District of Missouri. [ECF No. 1789].
- 2. In the years preceding the Debtors' bankruptcy, Jackson Kelly routinely and continually provided substantial professional legal services to the Debtors relating to their coal mining activities in West Virginia and Kentucky. At the time the Debtors first sought bankruptcy protection, Jackson Kelly had nearly 300 open and active matters for the Debtors covering many areas of law including: mine safety and health, environmental regulation and compliance, federal black lung, legislative lobbying services, representation in commercial transactions, and other general litigation.
- 3. The Debtors have retained Jackson Kelly with this Court's authorization by its September 10, 2012, *Order Authorizing the Employment and Retention of Jackson Kelly PLLC as Special Counsel for the Debtors* Nunc Pro Tunc *to the Petition Date*, [ECF No. 540] (the "Jackson Kelly Employment Order") *nunc pro tunc* from the Petition Date to continue to render professional services in connection with (collectively, the "Authorized Representation"):

- (a) Environmental matters relating to the Debtors' coal leases, coal property, mines and other properties and installations;
- (b) Mine safety and health matters, including alleged violations of the Mine Safety and Health Act;
 - (c) The defense of Federal Black Lung cases;
 - (d) The defense of West Virginia deliberate intent litigation;
 - (e) Litigation on behalf of one or more of the Debtors as a party plaintiff;
 - (f) Litigation on behalf of one or more of the Debtors as a party defendant;
- (g) Local real estate and commercial transactions, as needed from time to time, which may not duplicate services provided by the Debtors' other counsel;
 - (h) Local legislative and lobbying services; and
 - (i) Representation of one or more of the Debtors in arbitration issues.
- 4. The Court's December 5, 2012, *Order Authorizing the Payment for Certain Services on a Fixed Fee Basis to Jackson Kelly PLLC* [ECF No. 1677] (the "Fixed Fee Order"), amended the Jackson Kelly Employment Order to permit fixed fee billing for local legislative and lobbying services at a rate of \$2,500 per month *nunc pro tunc* to the Petition Date.
- 5. The Court's October 25, 2013, *Order Granting in Part Debtors' Omnibus Application to Expand Retention of Professionals to Include New Debtors* [ECF No. 4865] (the "Expansion Order") expanded the employment of Approved Firms, including Jackson Kelly, to encompass representation of New Debtors, Brody Mining, LLC and Patriot Ventures LLC ("New Debtors," and hereinafter with the Debtors, the "Debtors") effective as of September 23, 2013.

- 6. In providing Authorized Representation services to the Debtors, Jackson Kelly has striven to minimize costs and prevent duplication of services whenever possible.
- 7. On July 18, 2012, the Office of the United States Trustee for the Southern District of New York (the "<u>U.S. Trustee</u>")⁶ appointed the Creditors' Committee pursuant to sections 1102(a) and 1102(b) of the Bankruptcy Code. No trustee or examiner has been appointed in the Debtors' chapter 11 cases.
- 8. On December 18, 2013, the court entered the *Amended Order Confirming Debtors' Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code* [ECF No. 5169], confirming the Debtors Fourth Amended Joint Plan of Reorganization.
- 9. On January 7, 2014, the court issued a *Notice of Hearing and Related Procedures for Final Fee Applications of Retained Professionals* [ECF No. 5205] requiring that all professionals retained in this case pursuant to sections 327(a) or 327(e) of the Bankruptcy Code file applications for final Court approval and allowance of compensation and reimbursement of expenses no later than January 31, 2014.

JURISDICTION

10. This Court has subject matter jurisdiction to consider and determine this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

References to the "U.S. Trustee" herein refer to the United States Trustee for the Southern District of New York and/or the United States Trustee for the Eastern District of Missouri where applicable.

SUMMARY OF REQUESTED PROFESSIONAL COMPENSATION AND REIMBURSEMENT OF EXPENSES

- 11. This Application has been prepared in accordance with (a) the Local Rules of Bankruptcy Procedure and accompanying Procedures Manual for the United States Bankruptcy Court for the Eastern District of Missouri (the "Local Guidelines"), (b) the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330 (the "UST Guidelines") and (c) the Order to Establish Procedures for Interim Monthly Compensation and Reimbursement of Expenses of Professionals [ECF No. 262] (the "Interim Compensation Order" and, collectively with the Local Guidelines and the UST Guidelines, the "Guidelines").
- 12. Jackson Kelly previously requested compensation from the Court for professional services and reimbursement of expenses by its First Interim Application for Allowance of Compensation and Reimbursement of Expenses, [ECF No. 1592] (the "First Fee Application"). On December 19, 2012, the Court granted Jackson Kelly's First Fee Application, [ECF No. 1788], and Jackson Kelly received payment of \$239,458.98 for professional fees and \$21,919.09 in expenses for the time period covered by the First Fee Application.
- 13. Jackson Kelly's Second Interim Application for Allowance of Compensation and Reimbursement [ECF No. 3649] (the "Second Fee Application") was granted on May 23, 2013 [ECF No. 4050], and Jackson Kelly was paid \$312,505.74 for professional fees and \$28,555.38 for expenses incurred during the time period covered by the Second Fee Application.
- 14. Jackson Kelly's Third Interim Application for Allowance of Compensation and Reimbursement [ECF No. 4599] (the "Third Fee Application") was granted in part and denied

in part on November 8, 2013 [ECF No. 4976], and Jackson Kelly was paid \$412,545.70 for professional fees and \$34,142.55 for expenses incurred during the time period covered by the Third Fee Application.

- 15. In accordance with the Interim Compensation Order, Jackson Kelly filed monthly fee statements for fees and expenses for the months of August 2013 [ECF No. 4656], September 2013 [ECF No. 4829], October 2013 [ECF No.5017], November 2013 [ECF No. 5168], and December 2013 [ECF No. 5221].
- 16. This Application seeks full compensation for 2,950.7 hours of professional services rendered to the Debtors during the Fourth Compensation Period, in the aggregate amount of \$607,516.90, and for reimbursement of actual, necessary expenses incurred in connection with such services in the aggregate amount of \$29,152.94, totaling \$636,669.84. Pursuant to the Interim Compensation Order, Jackson Kelly has been paid a total of \$456,134.38 to date, comprising \$432,929.12 for professional services and \$23,205.26 for reimbursement of expenses incurred during the months of August 2013 November 2013. By the time this application is heard, Jackson Kelly expects that, in the ordinary course, it will have also been paid \$53,084.40 in professional fees and \$5,947.68 in expenses for December 2013. Total compensation paid on the day of hearing is expected to be \$515,166.46. Upon approval of this Fourth and Final Fee Application, Jackson Kelly may be paid the remaining \$121,503.38 outstanding, representing the Court-ordered 20% holdback of Jackson Kelly's total fees for the Compensation Period.
- 17. In addition, by this Application, Jackson Kelly seeks final allowance in full of compensation for professional services rendered to the Debtors during the Entire Compensation Period in the aggregate amount of \$1,573,290.32 and for reimbursement of actual, necessary

expenses incurred in connection with the rendering of such services in the aggregate amount of \$113,769.96. During the Entire Compensation Period, Jackson Kelly attorneys and paraprofessionals expended a total of 7,646.31 hours for which compensation is sought.

- 18. Except as permitted under the Interim Compensation Order, Jackson Kelly has received no payment and no promises of payment from any source for services rendered or to be rendered in any capacity whatsoever in connection with the matters covered by this Application during the Fourth Compensation Period. There is no agreement or understanding between Jackson Kelly and any other person, other than partners of the firm, for the sharing of compensation to be received for services rendered in these cases.
- 19. The fees charged by Jackson Kelly for its Authorized Representation of the Debtors are billed in accordance with agreed-upon billing rates and procedures in effect during the Fourth Compensation Period. The rates charged by Jackson Kelly for services rendered in connection with these chapter 11 cases do not (and will not) exceed Jackson Kelly's standard rates and charges for services rendered in comparable matters. Further, these fees are reasonable in comparison with the rates charged by comparably skilled practitioners in comparable matters in the regional markets where Jackson Kelly actively practices law.
- 20. Prior to filing this Application, Jackson Kelly filed monthly fee statements setting forth Jackson Kelly's fees for professional services rendered and expenses incurred August 1, 2013 through December 31, 2013 with the Court; copies of those statements were provided to the Debtors, Debtors' counsel (Davis Polk & Wardwell LLP), the U.S. Trustee, counsel to the Creditors' Committee, and counsel to the Debtors' postpetition lenders.
- 21. Pursuant to the UST Guidelines, the U.S. Trustee summary section preceding this Application includes a schedule setting forth all Jackson Kelly professionals and

paraprofessionals who have performed services in connection with these chapter 11 cases during the Fourth Compensation Period and the Entire Compensation Period. For each Jackson Kelly professional and paraprofessional, these schedules list the individual's name, area of practice, hourly billing rate, aggregate number of hours worked and fees billed, and, where applicable, the year and state in which each professional was first licensed to practice law.

- 22. <u>Exhibit A</u> is a schedule listing the actual and necessary expenses for which Jackson Kelly seeks reimbursement.
- 23. Pursuant to the UST Guidelines, <u>Exhibit B</u> is a summary of the number of hours and amounts billed by Jackson Kelly during the Fourth Compensation Period and the Entire Compensation Period, organized by area of law.
- 24. <u>Exhibit C</u> provides a detailed itemization of actual and necessary mileage and travel expenses incurred during the Fourth Compensation Period.
- 25. Jackson Kelly maintains computerized records of the time spent by all Jackson Kelly attorneys and paraprofessionals in connection with its Authorized Representation Debtors.⁷

SUMMARY OF SERVICES

26. During the Fourth Compensation Period, Jackson Kelly provided professional services to the Debtors in 167 active matters covered by the Jackson Kelly Employment Order. Since reciting each and every item of professional service would be extremely burdensome, the major areas of law to which Jackson Kelly devoted time and attention during the Fourth Compensation Period are summarized below. Exhibit B provides a detailed breakdown of the

Detailed time records were filed with Jackson Kelly's monthly fee statements for August 2013, [ECF No. 4656], September 2013, [ECF No. 4829], October 2013, [ECF No. 5017], November 2013, [ECF No. 5168], and December 2013 [ECF No. 5221], which are hereby incorporated by reference.

time devoted and fees allocable to each area of law, and is further broken down into discrete matters.

(a) Federal Black Lung

Jackson Kelly provided professional services in 22 separate and discrete Federal Black Lung matters during the Fourth Compensation Period. The total number of hours billed was 170.7. The total fees related to Black Lung matters were \$30,755.20.

The Debtors are party to numerous disputes regarding their alleged obligation to pay Federal Black Lung benefits to former individuals claiming to be suffering from coal workers pneumoconiosis, also known as black lung disease. In relation to these matters and issues, during the Fourth Compensation Period, Jackson Kelly performed work including:

- Reviewing claimants' medical records;
- Planning defense strategy;
- Attending and participating in depositions of medical experts;
- Drafting numerous notices, motions, and memoranda; and
- Representing the Defendant's at hearings before administrative law judges.

(b) Commercial Transactions

During the Fourth Compensation Period, Jackson Kelly represented Patriot Coal Corporation in one commercial transaction involving the assignment of membership interests in RMWV, LLC. In this capacity, Jackson Kelly billed a total of 65.6 hours, totaling \$17,569.00 in legal fees.

(c) West Virginia Deliberate Intent Litigation

Jackson Kelly billed a total of 3.4 hours on matters related to West Virginia deliberate intent litigation during the Fourth Compensation Period, the total fees of which amounted to \$635.80.

(d) Environmental

Jackson Kelly billed 123.8 hours during the Fourth Compensation Period for 13 environmental matters, amounting to \$29,828.00 in fees. Several of the Debtors' mining operations are subject to various environmental requirements, and failure to comply with these requirements could jeopardize the Debtors' continued operations at subject mines. During the Fourth Compensation Period, Jackson Kelly worked on matters including:

- Reviewing, analyzing and researching various permitting and environmental compliance issues; and
- Representing the Debtors in various matters before the West Virginia Department of Environmental Protection, Surface Mining Board, and related appeals.

(e) Mine Safety and Health

Jackson Kelly provided professional services in 123 Mine Safety and Health matters during the Fourth Compensation Period. The total number of hours billed was 2,455.00, totaling \$481,560.90 in fees. Mine Safety and Health citations – in widely varying degrees of severity – are an unavoidable part of the coal mining industry. These citations are usually resolved through either administrative litigation or by negotiated settlements between the operator and the United States Department of Labor. In relation to these matters and issues, during the Compensation Period, Jackson Kelly represented the Debtors in relation to citations, Notices of Violations ("NOVs"), and Pattern of Violation notices ("POVs"), including:

- Investigating and analyzing citations;
- Developing litigation strategies;
- Drafting pleadings, motions, and position statements;
- Representing the Debtors at depositions;
- Conducting and responding to discovery;
- Preparing for and representing the Debtors at administrative conferences, hearings, and trials;
- Negotiating settlements for numerous Mine Safety and Health citations; and
- Analyzing and challenging the new POV Final Rule, 78 Fed. Reg. 5056 (Jan. 23, 2013).

(f) Real Property

A total of 70.10 hours were billed for a judgment and lien search related to a 2013 refinancing for Patriot Coal Corporation during the Fourth Compensation Period, totaling \$18,125.00 in fees.

(g) Workers Compensation

A total of 27.3 hours were billed for matters related to Workers Compensation, totaling \$8,035.00 in fees. During the Fourth Compensation Period, Jackson Kelly represented the debtor in matters relating to recovery of overpayments to the West Virginia Insurance Commission and a self-insured audit.

(h) Bankruptcy

A total of 34.8 hours were billed for work relating to preparation of Jackson Kelly's fee statements and applications. The total fees relating to this project were \$8,508.00. In addition to a small amount of work relating to the Debtors' reorganization, Jackson Kelly worked to ensure its monthly fee statements and interim fee applications were in compliance with applicable guidelines, court rules, and court orders in seeking compensation in its role as special counsel.

(i) Legislation

Jackson Kelly provides local legislative and lobbying services for the Debtors throughout the year at a fixed rate of \$2,500.00 per month pursuant to the December 9, 2012, Fixed Fee Order.

27. The foregoing professional services performed by Jackson Kelly were necessary and appropriate to the Authorized Representation in connection with Debtors' chapter 11 cases. These services were in the best interests of the Debtors and other parties in interest. Compensation for the foregoing services as requested is commensurate with the complexity, importance and nature of the problems, issues and tasks involved. The services were performed in an efficient manner.

ACTUAL AND NECESSARY EXPENSES

- 28. As set forth in Exhibit A hereto, Jackson Kelly has incurred or disbursed \$29,152.94 in expenses in providing professional services to the Debtors during the Fourth Compensation Period. These expenses cover Jackson Kelly's direct operating costs that are not incorporated into Jackson Kelly's hourly billing rates. Clients are charged separately for services of the types set forth in Exhibit A on a per use basis. If these costs were, instead, built into the general rates, low-use clients would effectively subsidize the expenses incurred by high-use clients.
- 29. The majority of these expenses relate to copies, special postage, research, depositions, experts, and the like. In accordance with the Guidelines, photocopying expenses are calculated at Jackson Kelly's cost-- \$0.10 per page. On several occasions, documents or materials had to be shipped at extra cost to meet deadlines. Consistent with the Guidelines,

Jackson Kelly does not seek reimbursement for any expenses to deliver documents to its employees' homes.

- 30. Travel expenses and mileage for the Fourth Compensation Period, which comprise less than \$5,500 in expenses, are itemized in Exhibit C.
- 31. Jackson Kelly has made every effort to minimize its expenses in providing the Authorized Representation. The actual expenses incurred in providing professional services to the Debtors were absolutely necessary, reasonable and justified under the circumstances to serve the needs of the Debtors.

THE REQUESTED COMPENSATION AND EXPENSE REIMBURSEMENT SHOULD BE ALLOWED

32. Section 331 of the Bankruptcy Code provides for compensation of professionals and incorporates the substantive standards of section 330 to govern the Court's award of such compensation. 11 U.S.C. § 331. Section 330 provides that a court may award a professional employed under section 327 of the Bankruptcy Code "reasonable compensation for actual, necessary services rendered . . . and reimbursement for actual, necessary expenses." *Id.* § 330(a)(1). Section 330 also sets forth the criteria for the award of such compensation and reimbursement:

In determining the amount of reasonable compensation to be awarded . . . , the court shall consider the nature, the extent, and the value of such services, taking into account all relevant factors, including:

- (A) the time spent on such services;
- (B) the rates charged for such services;
- (C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;

- (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed;
- (E) with respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field; and
- (F) whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title.

11 U_S.C. § 330(a)(3).

- 33. Local Rule 2016(1)(B) requires that all professional fee applications analyze the 12 factors for allowance of compensation set forth in *Johnson v. Georgia Highway Express*, 488 F.2d 714 (5th Cir. 1974) (the "*Johnson* Factors").
- 34. Jackson Kelly submits that its Application satisfies all of the *Johnson* Factors, as described below.

(a) Time and labor required.

In Jackson Kelly's role as special counsel to the Debtors during the Fourth Compensation Period, it represented the Debtors in 167 matters, which required extensive time and effort, often times in the face of significant time constraints.

(b) The novelty and difficulty of questions.

During the Fourth Compensation Period, Jackson Kelly represented the Debtors in a wide range of matters involving varying degrees of novelty and complexity. Many matters involved complicated legal issues requiring a high degree of skill and specialization.

(c) The skill required to perform legal services property.

Jackson Kelly believes that its lawyers have demonstrated the skill levels necessary for the vigorous representation of the Debtors' interest in rendering Authorized Representation during the Fourth Compensation Period.

(d) The preclusion of employment due to acceptance of the case.

Jackson Kelly's agreement to provide the Authorized Representation to the Debtors has precluded Jackson Kelly from significant other employment opportunities. Jackson Kelly has declined numerous requests for representation of secured and unsecured creditors of the Debtors, several lessors of the Debtors, and at least one opportunity to represent a potential purchaser of some of the Debtors' assets. Jackson Kelly has also declined miscellaneous other employment that would have been adverse to the Debtors.

(e) The customary fee.

The rates charged by Jackson Kelly in representing the Debtors are consistent with the rates charged to the Debtors prior to their bankruptcy. These rates are at, or in many instances, lower than the rates it charges other clients on similar matters.

(f) Whether the fee is fixed or contingent.

The fees requested herein are on a fixed basis. As explained in Paragraph 3, local legislative and lobbying services are provided to the Debtors at a fixed rate of \$2,500 per month. All other Authorized Representation is rendered on an hourly basis.

(g) <u>Time limitations imposed by the client or the circumstances.</u>

Many of the 167 matters involved significant time constraints and limitations.

(h) The amount involved and the results obtained.

Jackson Kelly worked diligently and efficiently to provide Authorized Representation to the Debtors. While the results in all 167 matters may not have been uniformly favorable, many

have been, and, overall, the results have been exceptional given the particular circumstances of the specific matters.

(i) The experience, reputation and ability of the attorneys.

The professionals representing the Debtors in providing the Authorized Representation are highly skilled and experienced in the areas of law in which they provided representation.

(j) The undesirability of the case.

Jackson Kelly has been privileged to represent the Debtors in the years leading up to these bankruptcy proceedings and is privileged to continue to do so during their reorganization.

(k) The nature and length of professional relationship with client.

Jackson Kelly has a long-standing relationship with the Debtors and has provided extensive legal services to the Debtors for years prior to their Chapter 11 proceedings.

(l) <u>Awards in similar cases</u>.

The fees requested in this Application are less than would have been requested for similar representation in comparable matters.

35. Jackson Kelly respectfully submits that the services for which it seeks compensation and the expenditures for which it seeks reimbursement in this Application were necessary for and beneficial to the orderly administration of the Debtors' estates and their rehabilitation and reorganization effort. Jackson Kelly has continued to diligently assist the Debtors during the pendency of their bankruptcy case. The services and expenditures associated with Jackson Kelly's services were necessary to and in the best interests of the Debtors' estates and creditors. Moreover, the compensation requested herein is reasonable in light of the nature, extent, and value of these services to the Debtors, their estates and all parties in interest.

- 36. Whenever possible, Jackson Kelly sought to minimize the costs of its services to the Debtors by utilizing talented junior attorneys and paraprofessionals to handle more routine aspects of case administration.
- 37. In sum, approval of the compensation for professional services and reimbursement of expenses sought herein is warranted.

WHEREFORE, Jackson Kelly respectfully requests (i) an allowance of compensation for professional services rendered during the Fourth Compensation Period in the amount of \$636,669.84 and reimbursement of actual and necessary expenses Jackson Kelly incurred during the Fourth Compensation Period in the amount of \$29,152.94; (ii) final allowance and payment of compensation for professional services rendered during the Entire Compensation period in the amount of \$1,573,290.32 and reimbursement of actual and necessary expenses Jackson Kelly incurred during the Entire Compensation Period in the amount of \$113,769.96 (which amounts include fees and expenses requested for the Fourth Compensation Period); and (iii) such other and further relief as is just.
