STIPULATION AND ORDER ESTIMATING CLAIMS OF THE LRPB GROUP

Patriot Coal Corporation and its subsidiaries that are Reorganized Debtors in these jointly-administered cases (collectively, the "Reorganized Debtors") and the creditors listed on <u>Exhibit A</u> hereto (collectively, the "LRPB Group") hereby stipulate and agree as follows.

1. The LRPB Group has filed the claims listed on Exhibit A, each of which asserts a contingent and unliquidated claim (the "Contingent Claims").

2. Each of the Contingent Claims arises from the Restatement of Leases and Other Documents dated September 28, 1984 among LaFollette, Robson, Prichard & Broun, *et al.* and Cedar Coal Co. and The Charleston Bank, N.A., as Trustee (as amended, assigned (in whole or in part), transferred, extended, subleased or as the rights derived from that certain lease were conveyed or assumed from time to time, the "LRPB Lease"). With respect to the LRPB Lease, each member of the LRPB Group filed certain claims for fixed and liquidated amounts owed by the Debtor-Lessee (the "Fixed Claims") and one Contingent Claim for contingent and unliquidated amounts that may be owed by the Debtor-Lessee in certain circumstances.

3. The Reorganized Debtors have assumed the LRPB Lease pursuant to Section 365 of the Bankruptcy Code. In a Stipulation and Order entered on March 20, 2013 [Docket No. 3332] (the "Lease Assumption Order"), the Reorganized Debtors and the LRBP Group agreed to the cure amounts necessary to cure then existing defaults under the LRPB Lease pursuant to Section 365(b) of the Bankruptcy Code (the "Cure Amounts"). The Reorganized Debtors have paid the Cure Amounts. By Amended Order dated June 25, 2013 [Docket No. 4216], the Court disallowed the Fixed Claims as having been paid.

4. As part of the Lease Assumption Order, the Debtors and the LRPB Group also agreed that the Cure Amounts did not include "(i) any defaults that are not yet in existence, or (ii) any amount or obligation on account of any presently contingent or unliquidated claims arising from or relating to any environmental condition, claim, or obligation (if any), in each case to the extent provided for under the LRBP Lease," and that the right to assert any such claims was expressly preserved.

5. In addition, Section 74 of the Order Confirming Debtors' Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code (the "Confirmation Order")¹ states the following:

<u>Potential LRPB Claims</u>. Nothing in the Plan (including, without limitation, Section 11.4 thereof) or this Confirmation Order, shall (i) release, waive, or discharge the Potential LRPB Claims or (ii) preclude the LRPB Lessors from prosecuting the Potential LRPB Claims against the Reorganized Debtors and/or any other person or entity to the fullest extent permitted by applicable law from and after the Effective Date. Nothing in the Plan or this Confirmation Order or any other order or decree entered into after November 1, 2013 shall be deemed to impair, bar or estop the LRPB Lessors from exercising their rights (i) available pursuant to applicable law or (ii) set forth in the LRPB Lease, in each case from and after the Effective Date.

6. The Reorganized Debtors and the LRPB Group now stipulate and agree that the fixing or liquidating of the Contingent Claims would unduly delay the administration of these cases and that each of the Contingent Claims should be estimated at \$0.00 for purposes of distribution or related administrative matters.

7. Except for the estimation of the Contingent Claims at \$0.00 for purposes of distribution or related administrative matters, nothing herein shall affect the rights of the LRPB Group as set forth in the Confirmation Order and Plan.

8. The Clerk of the Court and the Reorganized Debtors' claims agent are hereby directed to reflect the estimation of the claims, as specified above, in their respective records.
