STIPULATION AND ORDER REGARDING OBJECTION TO CLAIM OF CONTINENTAL BANK

Patriot Coal Corporation and its subsidiaries that are Reorganized Debtors in these jointly-administered cases (collectively, the "Debtors" or the "Reorganized Debtors") and Continental Bank hereby stipulate and agree as follows.

- 1. On June 20, 2013, the Reorganized Debtors filed their Fifth Omnibus Objection to Claims (Wrong Debtor or Otherwise Inconsistent with Books and Records) [Docket No. 4181] (the "Objection").
- 2. In the Objection, the Reorganized Debtors proposed to disallow secured Claim No. 2304 (GCG Claim No. 3674) filed by Continental Bank in the amount of \$1,526,868.00 because the Reorganized Debtors' books and records demonstrated that the underlying obligation appeared to be to a creditor other than Continental Bank.
- 3. The Reorganized Debtors and Continental Bank now stipulate and agree that Claim No. 2304 (GCG Claim No. 3674) should be modified to be allowed in the unsecured amount of \$557,276.00.
- 4. The Objection is hereby SUSTAINED IN PART and DENIED IN PART as described above.
