2014 I SAID I WILL NOT HAVE INSURANCE COVERAGE
MARCH 31 2014 THIS IS NOT WHAT I WAS REFERRING
TO AS I WAS AWARE THAT U.M.R. WAS TO REPLACE
UNITED HEALTH CARE. U.M.R. WAS MY INSURANCE
FOR SEVERAL YEARS PRIOR TO CHANGE TO UNITED-
HEALTH CARE ONE OF THE PROBLEMS WITH UNITED
HEALTH CARE IS I HAVE SEVERAL BILLS OUTSTANDING
FROM LAST ABOUT AUGUST 2013 WHEN I HAD A
PROBLEM WITH MY HEART AND WAS PUT ON
A MONITORING SYSTEM FOR 30 DAYS WHICH I
WORE DAY NIGHT WITHSTANDING SOME PROBLEMS

I HAD WITH THE MONITORING DEVICE NOT WORKING PROPERLY BUT THE PROBLEM IS WITH THE BILL FROM THE MONITORING SYSTEM HAS NOT BEEN PAID TO THE SUM OF \$11,600.00 OR THEIR ABOUT AS UNITED HEALTH CARE HAS BEEN SENDING BILLS UP AND BACK FOR MONTHS. ON MARCH 3 2014 I WENT TO SEE HEART DOCTOR WHO PLACED ME ON A MONITORING SYSTEM.
