THE ADDRESS ABOUT 15 YEARS AGO BUT STILL  
SAME PLACE MORE THAN 20 YEARS SINCE  
RECEIVED PLAN. YOUR HONOR AS I SAID  
IN YOUR COURT ROOM ON FEBRUARY 25-10:00  
I CAN'T SAY ANY THING GOOD ABOUT THE  
U.M.W.A AS TO THE WAY I FEEL  
I HAVE BEEN TREATED SINCE MY  
DISABLING ACCIDENT SEPT 1987

IT TOOK A VERY LONG TIME BEFORE  
I RECEIVED ANY MONEY AS IN  
AUGUST OF 1988 I APPEARED WITH  
MY ATTORNEY IN THE THOMAS F.  
EAGLETON U.S. COURT HOUSE SOCIAL SECURITY  
OFFICE OF HEARING IN THE OLD  
PART OF FEDERAL BUILDING AS MY  
ATTORNEY AT THAT TIME WAS LOCATED  
IN A OFFICE NORTH OF FEDERAL BLDG.  
AS I REMEMBER WALKING ACROSS THE  
BIG STREET TO FEDERAL BLDG. (OLD)  
IN THE MONTH FOLLOWING MY APPEARANCE  
AT SOCIAL SECURITY BLDG IN FRONT  
OF A LAW JUDGE I WAS GRANTED  
SOCIAL SECURITY WITH BACK PAY  
FROM TIME OF MY ACCIDENT ON SEPT.  
1987 AT ARCH OF ILLINOIS PIPESTONE  
CREEK MINE WHERE I WAS A SHOOTER  
ON THE DRILLS. AFTER RECEIVING  
SOCIAL SECURITY DISABILITY I THEN  
APPLIED TO THE U.M.W.A. HEALTH  
AND RETIREMENT FUNDS AT THAT TIME  
IN WASHINGTON D.C. I DON'T REMEMBER  
THE EXACT ADDRESS IN 1988 HOWEVER  
I WAS TOLD TO GO TO LOCAL U.M.W.A.  
DISTRICT 12 OFFICE AT BENTON, IL

WHICH IS ABOUT 10 MILES FROM MY HOME AT SENSERIL THE FRIST EXPERIENCE I HAD WITH THE U.M.W.A. STARTED IN 1988 AFTER I RECEIVED SOCIAL SECURITY DISABILITY AND MY EXPERIENCE AFTER THAT DATE ONLY GOT WORSE TALK ABOUT THE RUN AROUND I GOT MY FAIR SHARE AND I WAS IN POOR HEALTH FROM ACCIDENT THEY DID NOT CARE (U.M.W.A.) I FINALLY AFTER ABOUT A YEAR + ONE HALF I FINALLY GOT MY PRIST CHECK FOR \$316.16 THAT IS STILL THE SAME AMOUNT TODAY 26 YEARS LATER \$316.16 EACH MONTH

I LOOKED OVER THE U.M.W.A. 1974 PENSION PLAN SENT TO ME DATED FEBRUARY 2014 AND SEE ALL THE DISABILITY + RETIREMENT LARGE SUMS OF MONEY \$1300.00 UP TO \$1960.50 PER MONTH AND I DISLIKE U.M.W.A. EVEN MORE TODAY AS I AM ABOUT TO LEAVE MY HOME OF THE LAST 40 YEARS AND I THINK BACK TO WHEN I WENT TO U.M.W.A OFFICE AND TRYED IN ABOUT 1993-1994 TO GET MY DISABILITY PENSION RAISED TO \$500.00 AT THAT TIME WAS ABOUT THE GOING RATE FOR A DISABLED

I WENT TO U.M.W.A DISTRICT 12 OFFICE  
IN BENTON AND MET WITH A U.M.W.A  
REPRESENTATIVE NAMED (RICK TYGETT)  
AND IN SO MANY WORDS I WAS TOLD  
I HAD BETTER BE HAPPY WITH MY  
\$316.16 AND NOT CAUSE ANY PROBLEMS  
HERE AT THIS OFFICE AND TO BE  
DAMN LUCKY I GET THE \$316.16  
PER MONTH AS IF I CAUSED ANY  
PROBLEMS I MIGHT RECEIVE  
MORE THAN I EXPECTED! USE  
YOUR IMAGINATION AS TO WHAT  
THAT MEANT AND I NEVER WENT  
BACK TO THAT OFFICE IN BENTON OR  
QUESTIONED ANYONE IN THE U.M.W.A.  
FOR FEAR OF REPERCUTIONS BUT  
TODAY AT MY SOON TO BE AGE OF 65  
I DON'T HAVE ANY FEARS ANYMORE  
ALSO FROM THE U.M.W.A PERSON PLAN  
AROUND THE END OF THE YEAR I WOULD  
RECEIVE A CHRISTMAS AMOUNT OF ABOUT  
\$300.00 TO \$400.00 FOR XMAS BUT HAVE  
NOT RECEIVED THIS ONLY A FEW TIMES  
IN 26 YEARS "SURPRISE" TO END THIS  
LETTER I HAVE HAD VERY BAD

EXPERIENCES WITH THE U.M.W.A. AND ITS REPRESENTATIVES AND I KNOW FROM TALKING TO OTHER COAL MINERS THE AMOUNT I RECEIVE FOR THE PAST 26 YEARS IS VERY VERY WRONG \$316.16

ENCLOSED YOUR HONOR YOU WILL FIND THE U.M.W.A. PERSON PLAN DATED FEBRUARY 2014 OR REFERRED TO BY ATTORNEY BRYAN CAVE DATED MARCH 26 2014 TO MYSELF BASICALLY SAYING I WILL RECEIVE BENEFITS I AM ENTITLED TO RECEIVE PURSUANT TO THE COAL ACT, THIS IS JUST SOME OF THE EXPERIENCES I HAVE BEEN THRU WITH THE COAL MINERS AND THE U.M.W.A. PAST 26 YEARS IT IS A STRUGGLE EVERY DAY JUST TO SURVIVE AND NOW TOWARD THE ENTIREM OF MY LIFE I AM JUST WORE OUT & TIRED OF FIGHTING EVERY DAY JUST TO GET BY BEARLY SURVIVING. YOUR HONOR I RESPECTFULLY REQUEST YOU ALLOW MY CLAIM OF \$750,000.00 SO I CAN PAY AND TAKE CARE MY NEEDS (HEALTH) FOR THE REST OF MY LIFE.
