**DEBTORS' FOURTH OMNIBUS OBJECTION TO CLAIMS**  
**(Duplicate Beneficial Noteholder Claims)**

Patriot Coal Corporation (“Patriot”) and its affiliated debtors (collectively, the “Debtors”), pursuant to 11 U.S.C. § 502 and Fed. R. Bankr. P. 3007, respectfully file this Fourth Omnibus Objection to Claims (the “Objection”). In support of the Objection, the Debtors show the Court as follows:

**Relief Requested**

1. By this Objection, the Debtors object to certain claims listed on Exhibit A attached hereto (the “Note Claims”) because the Note Claims are duplicates of other proofs of claim filed by the indenture trustees for the Debtors’ two series of notes. The Debtors request entry of an order, pursuant to Section 502 of the Bankruptcy Code and Fed. R. Bankr. P. 3007, finding that the Note Claims are duplicative and directing that the Note Claims be disallowed and expunged.

2. **Parties receiving this Objection should locate their names on Exhibit A.** Any response to this Objection should include, among other things, (i) an appropriate caption, including the title and date of this Objection; (ii) the name of the claimant, both the EDMO and

GCG claim numbers of the claim that the Debtors are seeking to disallow and expunge, and a description of the basis for the amount claimed; (iii) a concise statement setting forth the reasons why the Court should not sustain this Objection, including, but not limited to, the specific factual and legal bases upon which the claimant relies in opposing this Objection; (iv) copies of any documentation and other evidence which the claimant will rely upon in opposing this Objection at a hearing; and (v) the name, address, telephone number and facsimile number of a person authorized to reconcile, settle or otherwise resolve the claim on the claimant's behalf. A claimant that cannot timely provide such documentation and other evidence should provide a detailed explanation as to why it is not possible to timely provide such documentation and other evidence.

### **Jurisdiction**

3. This Court has jurisdiction over this Objection under 28 U.S.C. § 1334. Venue of this proceeding is proper pursuant to 28 U.S.C. § 1409. This is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).

4. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

### **Background**

5. The Debtors filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code on July 9, 2012 in the United States Bankruptcy Court for the Southern District of New York.

6. On December 19, 2012, the Debtors' cases were transferred to the United States Bankruptcy Court for the Eastern District of Missouri [Dkt. No. 1789].

7. The bar date for filing proofs of claim was December 14, 2012 [Dkt. No. 1388].

8. On March 1, 2013, the Court entered its Order Establishing Procedures for Claims Objections [Dkt. No. 3021].

### **Objection and Argument**

9. The Debtors object to the Claims identified on Exhibit A, incorporated herein by reference, because they duplicate other claims filed against the Debtors.<sup>1</sup>

10. Exhibit A lists proofs of claim filed by claimants (the “Individual Noteholders”) seeking the repayment of principal and interest on the Debtors’ 8.25% Senior Unsecured Notes due 2018 and the Debtors’ 3.25% Convertible Senior Notes due 2013 (collectively, the “Notes”), which were issued by Patriot pursuant to trust indentures.

11. Wilmington Trust Company (“Wilmington Trust”), the Indenture Trustee of the 8.25% Senior Unsecured Notes due 2018, under that certain indenture dated as of May 5, 2010 (the “8.25% Senior Unsecured Notes”) filed Claim No. 1038 (GCG Claim No. 1857) against Patriot and related claims against each of the other Debtors. U.S. Bank National Association (“U.S. Bank”), the Indenture Trustee of the 3.25% Convertible Senior Notes due 2013, under that certain indenture dated as of May 28, 2008 (the “3.25% Convertible Senior Notes”), filed Claim No. 1537 (GCG Claim No. 2173) against Patriot and Claim No. 1536 (GCG Claim No. 2236) against all of the Debtors. The proofs of claim filed by Wilmington Trust and U.S. Bank (collectively, the “Global Proofs of Claim”) seek the repayment of principal, interest, and fees and expenses under the Notes and the related indentures on behalf of the beneficial holders of the Notes.

<sup>1</sup> Certain creditors listed on Exhibit A may be clients of one or more of the law firms representing the Debtors. Any dispute regarding this Objection will be handled by attorneys for the Debtors from a law firm that does not represent the applicable creditor.

12. Because the Notes are covered by one or more Global Proofs of Claim filed by Wilmington Trust or U.S. Bank (collectively, the “Indenture Trustees”), the Debtors submit that all of the Note Claims filed by the Individual Noteholders are duplicative of the Global Proofs of Claim filed by the Indenture Trustees. The Debtors, therefore, seek entry of an order disallowing and expunging from the claims register the Note Claims filed by the Individual Bondholders holding the 8.25% Senior Unsecured Notes and the 3.25% Convertible Senior Notes.

13. The Debtors have reviewed each of the Note Claims listed on Exhibit A. The Note Claims are duplicative of the Global Proofs of Claim. *See* Declaration of Robert L. Mead, attached hereto as Exhibit B.

14. To avoid the possibility of multiple recoveries by the Individual Bondholders of the 8.25% Senior Unsecured Note and the 3.25% Convertible Senior Notes, the Debtors request that the Court disallow and expunge in their entirety the Note Claims. On the effective date of a confirmed plan of reorganization, the Debtors will make distributions, if any, to Wilmington Trust as the Indenture Trustee of the 8.25% Senior Notes and U.S. Bank as the Indenture Trustee of the 3.25% Convertible Senior Notes. The Individual Noteholders, to the extent they are beneficial holders of the Notes as of the record date under a confirmed plan of reorganization, will receive distributions, if any, from Wilmington Trust as the Indenture Trustee of the 8.25% Senior Unsecured Notes and U.S. Bank as the Indenture Trustee of the 3.25% Convertible Senior Notes.

15. This Objection does not constitute an admission or finding concerning any of the Global Proofs of Claim. The Debtors reserve the right to object to any claim that is not disallowed in its entirety for any reason.

WHEREFORE, the Debtors respectfully request that this Court:

- (a) disallow and expunge the Note Claims; and
- (b) grant such other and further relief as is just and proper.
